

 During a sanitary survey conducted on 5/30/2012, the Mississippi State Department of Health cited the following significant deficiency(s).
 Inadequate internal cleaning/maintenance of storage tanks.
 Corrective actions: MSDH is currently working with this system to return them to compliance since the expiration of the compliance deadline. It is anticipated we will be returned to compliance by 9/30/2015.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
