A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Palmetto Water System have received higher susceptibility rankings to contamination.

We routinely monitor for contaminants in your drinking water according to Federal and State laws.
