### Disinfection By-Products Violation:

We routinely monitor for the presence of drinking water contaminants. Testing results we received show that our system exceeded the standard or maximum contaminant level (MCL) for Disinfection Byproducts for 4/01/2016-6/30/2016, 7/01/2016-9/30/2016 and 10/01/2016 -12/31/2016. The standard for Trihalomethanes (TTHM) is .080 mg/l and for Haloacetic Acids (HAA5) is .060 mg/l.

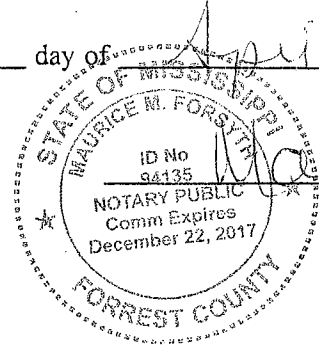
