We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water source is from wells drawing from the Catochula Formation and the Miocene Aquifers.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility assessments were made has been furnished to our public water system and is available for viewing upon request. The wells for the Willow Grove Water Association have received lower susceptibility rankings to contamination.
