We deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of water. We make the efforts we make to continually improve the water treatment process and protect our water resources of your water. Our water source is from wells drawing from the Eutaw Formation and Gordo Formation #

The source water assessment has been completed for our public water system to determine the overall health of the water system and to identify potential sources of contamination. A report containing detailed information on how the water system is performing is available for viewing upon request. The wells for the water system are ranked according to their susceptibility to contamination.

Customers can also be informed about their water utility. We routinely monitor for contaminants in your drinking water according to Federal and State laws. This report lists the contaminants that we detected during the period of January 1st to December 31st, 2016. In cases where the maximum level of a contaminant is exceeded, the table reflects the most recent results. As water travels over the surface of land or underground, it picks up various substances and contaminants from the presence of various sources. Some of these contaminants are naturally occurring, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural and urban storm-water runoff, and residential uses. Other contaminants are introduced into the water supply through domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides; fertilizers; and other agricultural, urban storm-water runoff, and residential uses. Some of these contaminants are naturally occurring, such as radon, which can be naturally occurring or be the result of oil and gas production. Some of these contaminants are introduced into the water supply through domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides; fertilizers; and other agricultural, urban storm-water runoff, and residential uses. - Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 hours.

Present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead enters the water supply primarily from materials and components associated with service lines and home plumbing. The Booneville Water System cannot control the variety of materials used in plumbing components. However, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before you use the water. If you are concerned about lead in your water, you may wish to have your water tested. In compliance with the "Regulation Governing Fluoridation of Community Water Supplies", the Booneville Water System is required to fluoridate its water system. The number of months in the previous year that the fluoride level was within the optimal range of 0.7-1.3 ppm was 0. The percentage of fluoride samples collected that were within the optimal range of 0.7-1.3 ppm was 0%.

Sources of drinking water are subject to potential contamination by substances that are not regulated by the SDWA, including microorganisms, inorganic and organic chemicals, and radioactive substances. All drinking water contains at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. 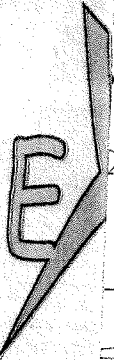

We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water source is from wells drawing from the Eutaw Formation and Gordo Formation Aquifers.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the City of Booneville have received a lower susceptibility ranking to contamination.

If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the first and third Tuesdays of each month at 7:00 PM at the Booneville City Hall located at 203 N. We routinely monitor for contaminants in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that we detected during the period of January 1st to December 31st, 2016. In cases where monitoring wasn't required in 2016, the table reflects the most recent results. As water travels over the surface of land or underground, it dissolves naturally occurring minerals and, in some cases, radioactive materials and can pick up substances or contaminants from the presence of animals or from human activity; microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm-water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm-water runoff, and residential uses; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations and septic systems; radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities. Parts per billion (ppb) or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

As you can see by the table, our system had no contaminant violations. We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some contaminants have been detected however the EPA has determined that your water IS SAFE at these levels.

We are required to monitor your drinking water for specific contaminants on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. We did complete the monitoring requirements for bacteriological sampling that showed no coliform present. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. If you are concerned about lead in your water, you may wish to have your water tested.
