During a sanitary survey conducted on 12/12/16, the MS State Department of Health cited the following significant deficiencies:

(1) Negative pressure that could result in contamination.

Corrective Action: MSDH is currently completing enforcement actions to return the system back into compliance by 4/30/18.

(2) Inadequate Pump Capacity

Corrective Action: MSDH is currently completing enforcement actions to return the system back into compliance by 6/30/18.
