The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Town of Lambert have received a moderate susceptibility ranking to contamination.

We routinely monitor for contaminants in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that we detected during the period of January 1st to December 31st, 2017. In cases where monitoring wasn't required in 2017, the table reflects the most recent results. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Monitoring and Reporting of Compliance Data Violations:

During a sanitary survey conducted on 6/21/2016, the Mississippi State Department of Health cited the following significant deficiency(s):

Inadequate security measures

Corrective Actions: MSDH is in the process of enforcement actions to bring this deficiency back into compliance by 6/30/18. This deficiency was corrected on 2/11/2018 and pictures were sent to MSDH. This system is back in compliance.

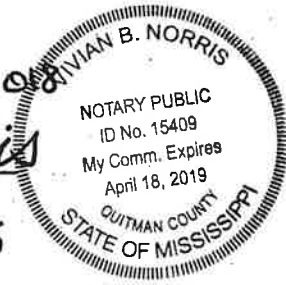
