The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Shady Grove Utility District have received lower susceptibility ranking to contamination.

We routinely monitor for contaminants in your drinking water according to Federal and State laws. In cases where monitoring wasn't required in 2018, the table reflects the most recent results.
