To comply with the "Regulation Governing Fluoridation of Community Water Supplies", the City of Kosciusko, PWS ID#0040004, is required to report certain results pertaining to fluoridation of our water system. The number of months in the previous calendar year in which the average fluoride sample results were within the optimal range of 0.6 - 1.2 ppm was 12. The percentage of fluoride samples collected in the previous calendar year that was within the optimal range of 0.6 - 1.2 ppm was 100%.

Additional Information for Lead

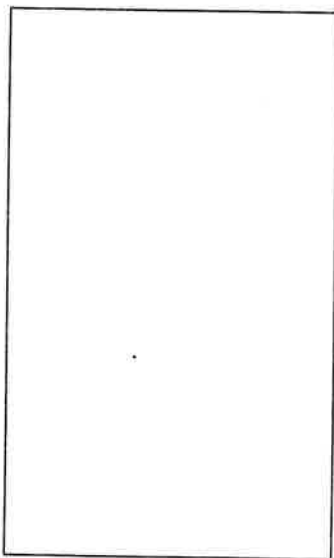
