Our goal is and always has been to provide you a safe and dependable supply of drinking water. Our water sources is one well that is drawn from the Meridian-Upper Wilcox Aquifer.

Source water assessment and its availability

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. The general susceptibility rankings assigned to this well on this system is provided immediately below. A report containing detailed information on how the susceptibility determinations were made had been furnished to our public water system and is available for viewing upon request. We are pleased to report that our drinking water meets all federal and state requirements.

The tables below shows the results of our monitoring period from January 1, 2015 to December 2015. As your water travels over land or underground, it can pick up substances or contaminates such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents.
