Beginning January 1, 2004, the Mississippi State Department of Health (MSDH) required public water systems that use chlorine as a primary disinfectant to monitor/test for chlorine residuals as required by the Stage 1 Disinfection By-Products Rule. Our water system has not failed to complete these monitoring requirements in 2018. We did complete the monitoring requirements for bacteriological sampling that show coliform present. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any missing samples prior to the end of the compliance period.

******A Message from MSDH Concerning Radiological Sampling ******

In accordance with Radionuclides Rule, all community public water supplies were required to sample quarterly for radionuclides beginning January 2007 – December 2007. Your public water supply completed sampling by the scheduled deadline; however, during an audit of the Mississippi State Department of Health Radiological Laboratory, the Environmental Protection Agency (EPA) suspended analyses and reporting of radiological compliance samples and results until further notice. The Bureau of Public Water Supply has taken action to ensure that your water system be returned to compliance by March 31, 2013.

Although this was not result of inaction by the public water supply, MSDH was required to issue a violation.
