We routinely monitor for the presence of drinking water contaminants. As water travels over the surface of land or underground, it dissolves naturally occurring minerals and, in some cases, radioactive materials and can pick up substainces or contaminants from the presence of animals or from human activity, microbial contaminants, such as viruses and bacteria; that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; horganic contaminants, such as salts and metals, which can be naturally occurring or result from urben storm-water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or residential uses; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations and septic systems; radioactive contaminants, which can be precyclibes. In order to ensure that tap water is sale to drink, EPA including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these contaminants does not necessarily indicate that the water posses a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Action Level - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system

Maximum Contaminant Level (MCL) - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The "Goal"(MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control microbial confaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) — The level of a drinking water disinfectant below which there is no known or expected risk of health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

(82) Total Trihalomethanes (TTHMs). Some people who drink whiter containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kildsoys, or central nervous systems, and may have an increased risk of getting capper.

We routinely monitor for the presence of drinking water contaminants. Testing results show that both our systems exceeded the standard or maximum contaminant level (MCL) for Disinfection Byproducts in all quarters of 2018. The standard for Trihalomethanes (TTHM) is .080 mg/1; As you can see in the charts we exceeded that amount. Aeration system has been installed to decrease TTHMs in our water, This has been in full operation since March 1, 2017. We should see a reduction in TTHM numbers.

If present, elevated levels of lead can cause serious health problems, especially for pregriant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
