The wells for the Town of Tchula have received moderate rankings in terms of susceptibility to contamination.

During June 2019, we did not complete all monitoring or testing for bacteriological and Chlorine contaminants and therefore cannot be sure of the quality of our drinking water during this time. We were required to take 2 samples and 0 were taken. We have since taken the required samples that showed we are meeting drinking water standards.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
