We are committed to ensuring the quality of your water and to providing you with this information, because informed customers are our best allies. Our water source is groundwater. Our wells draw from the Meridian Upper Wilcox and the Middle Wilcox Aquifers.

A Source Water Assessment has been completed for our public water system to determine the overall susceptibility of the drinking water supply and to identify potential sources of contamination. The general susceptibility rankings assigned to each well of this system are provided immediately below. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water supply and is available upon request. The wells for The City of Charleston have received a moderate ranking to contamination.

We are required to monitor your drinking water for specific contaminants on a monthly basis. In an effort to ensure systems complete all monitoring requirements, MSDH now notifies systems of any samples prior to the end of the monitoring period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Charleston is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been

sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
