We routinely monitor for contaminants in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that were detected during the period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2019. In cases where multiple water samples were taken in 2019, the table reflects the most recent results. As water travels over the surface of the earth, it dissolves naturally occurring minerals and, in some cases, radioactive materials and can pick up substances or contaminants from the presence of animals or from human activity. Minerals, pesticides, and other substances that may come from sewage treatment plants, septic systems, agricultural fertilizers, and various industrial operations, such as gas production, mining, or farming, pesticides, and herbicides, which may come from a variety of agricultural, urban, and other water uses and recreational uses, organic chemical solvents, including herbicides and volatile organic compounds, which are by-products of industrial processes and petroleum production, and can also come from gas stations and septic systems. Radioactive contaminants which can be naturally occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The important to remember that the presence of these contaminants does not necessarily indicate that the water poses a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

- Action Level** - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a public water system must follow.
- Maximum Contaminant Level Goal (MCLG)** - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLG as feasible using the best available treatment technology.
- Maximum Contaminant Level (MCL)** - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected health risk. MCLs are set as close to the MCLG as feasible.
- Primary Maximum Contaminant Level Goal (PMCLG)** - The highest level of a contaminant allowed in drinking water. There is no secondary or aesthetic effect of a contaminant in excess of this level.
- Secondary Maximum Contaminant Level Goal (SMCLG)** - The level of a drinking water contaminant below which there is no known or expected risk to health. SMCLGs do not enforce the aesthetic or health effects of a contaminant.
- Public Water System (PWS)** - A community water supply system that regularly serves at least 15 connections or regularly serves at least 25 people.
- Public Water System (PWS) (MCLG)** - The highest level of a contaminant allowed in drinking water. There is no secondary or aesthetic effect of a contaminant in excess of this level.

We are required to monitor your drinking water for specific contaminants on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. In an effort to ensure systems compliance, monitoring requirements, and the consequences of non-compliance, we are creating campaigns prior to the end of the compliance period.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water companies are responsible for replacing lead service lines. You can reduce the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are using a leaded faucet to dispense water, you may wish to use bottled water.
