Monitoring and Reporting of Compliance Data Violations:

The City of Belzoni failed to collect the required number of Lead and Copper samples during the period of 1/1/16 to 12/31/18. The required number of samples to collect was 20 and only 15 were collected.

Significant Deficiencies:

During a sanitary survey conducted on 1/8/2016, the MS State Department of Health cited the following significant deficiency(s): Well near source of fecal contamination (ex: septic systems, sewer lines)

Corrective Actions: This system is enrolled in the MSDH well abandonment program and is awaiting funds. The anticipated abandonment date is 12/31/2021.

Additional Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Belzoni is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
