We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water.

They are held on the first and third Tuesdays of each month at 5:30 PM at City Council Chambers located at 543 Main St.

Our water source is from wells drawing from the Graham Ferry Formation & Pascagoula Formation Aquifers. The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the City of Bay St. Louis have received a moderate susceptibility ranking to contamination.

We routinely monitor for contaminants in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that were detected during the period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2020. In cases where monitoring wasn't required in 2020, the table reflects the most recent results.
