Our water source is from wells drawing from the Meridian Upper Wilcox Aquifer.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. Our system # 820027 received a MCL violation for the Haloacetic Acids (HAA5) exceeded the Maximum Contaminant Level for the third quarter of 2021. Our system # 820028 received a MCL violation for the Haloacetic Acids (HAA5) exceeded the Maximum Contaminant Level for the fourth quarter of 2021. On 3/30/2021 this public water system (# 280010) was required by the MS State Department of Health, Bureau of Public Water supply to participate in an Administrative Hearing due to violations of the Disinfection By-Products Rule.

We are required to monitor your drinking water for specific contaminants on a monthly basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. On system # 820028 our system failed to collect the required sample for chlorine. We were required to collect 1 sample in June and collected 0. The required sample has since been taken that shows we are meeting drinking water standards.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Our water system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components.
