

We're pleased to present to you this year's Annual Quality Water Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to providing you with information because informed customers are our best allies.

If you have any questions about this report or concerning your water utility, please contact Damion Robinson at 662.545.6650. We want our valued customers to be informed about their water utility. If you want to learn more, please join us at any of our regularly scheduled meetings. They are held on the first Tuesday of the month at 6:00 PM at the Hazlehurst City Hall.

Our water source is from wells drawing from the Catahoula Formation Aquifer. The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the City of Hazlehurst have received a moderate ranking in terms of susceptibility to contamination.

We routinely monitor for contaminants in your drinking water according to Federal and State laws. This table below lists all of the drinking water contaminants that were detected during the period of January 1st to December 31st, 2021. In cases where monitoring wasn't required in 2021, the table reflects the most recent results. As water travels over the surface of land or underground, it dissolves naturally occurring minerals and, in some cases, radioactive materials and can pick up substances or contaminants from the presence of animals or from human activity; microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm-water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm-water runoff, and residential uses; organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations and septic systems; radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities. Significant Deficiencies

Monitoring and Reporting of Compliance Data Violations:

During a sanitary survey conducted on 5/14/2021, the Mississippi State Department of Health cited the following significant deficiency(s):

Source Water Quantity/Quality

Corrective Actions: The system is scheduled to complete corrective actions by 06/30/2021 using a compliance plan or are within the initial 120 days minimum. Our system has failed to meet the compliance deadline and is now in enforcement status and must appear before MSDH Enforcement and the state appointed Hearing Officer.

To comply with the "Regulation Governing Fluoridation of Community Water Supplies", the City of Hazlehurst is required to report certain results pertaining to fluoridation of our water system. The number of months in the previous calendar year in which average fluoride samples results were within the optimal range of 0.6 – 1.2 ppm was 2. The percentage of fluoride samples collected in the previous calendar year that was within the optimal range of 0.6 -1.2 ppm was 7%.

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or man made. These substances can be microbes, inorganic or organic chemicals and radioactive substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk.
