Our water source consists of 2 wells that draw from the Meridian Upper Wilcox Aquifer.

A source water assessment has been completed for the water supply to determine the overall susceptibility of its drinking water to identify potential sources of contamination. The water supply for the Town of Boyle received lower to moderate susceptibility rankings to contamination.

We're pleased to report that our drinking water meets all federal and state requirements.
