A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Tiptersville Water Association have received moderate rankings in terms of susceptibility to contamination.

We routinely monitor for contaminants in your drinking water according to Federal and State laws. In cases where monitoring wasn't required in 2021, the table reflects the most recent results.
