We are committed to providing you with information because informed customers are our best allies. Our water source is from wells drawing from the Sparta Aquifers.

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identified potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for our system have received lower rankings in terms of susceptibility to contamination.

If you are concerned about lead in your water, you may wish to have your water tested. 
