Our water source is from wells drawing from Miocene Formation Aquifer. The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Town of D'Lo have received a lower susceptibility ranking to contamination.

#### **Period Covered by Report**

We routinely monitor for contaminants in your drinking water according to federal and state laws. This report is based on results of our monitoring period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2022. In cases where monitoring wasn't required in 2022, the table reflects the most recent testing done in accordance with the laws, rules, and regulations.

The system is scheduled to complete corrective actions by 10/31/2023 using a compliance plan or are within the initial 120 days minimum.

We have received a grant to clean and paint our tanks. This will correct our deficiency. We hope to have this completed by October of 2023. Bids go out this month.
