

Included are details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and state standards. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water.

### Source of Water

Our water is drawn from the Forest Hill Sand Aquifer and Sparta Aquifer. Our source water assessment has been completed and our wells were ranked from Lower to Moderate in terms of susceptibility to contamination. To see a copy of the report please contact our office at 601-878-9639.

SCWA routinely monitors for constituents in your drinking water according to Federal and State laws. As water travels over the land or underground, it may pick up substances or contaminants such as microbes, inorganic or organic chemicals, and radioactive substances. All sources of drinking water are subject to potential contamination by substances that are naturally occurring or man made. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. It is important to remember that the presence of these constituents does not necessarily indicate that water poses a health risk.

Your water is treated with chlorine, a disinfectant to kill dangerous bacteria and microorganisms that may be in the water. Disinfection is considered to be one of the major public health advances of the 21<sup>st</sup> century. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. ### Terms and Abbreviations

In the following table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we have provided the following definitions.

#### Contaminants that may be present in source water before we treat it include:

- **Microbial contaminants**, such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- **Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban storm-water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- **Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban storm-water runoff, and residential uses.
- **Radioactive contaminants**, which are naturally occurring or be the result of oil and gas production and mining activities.
- **Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm-water runoff, and septic systems.

#### Terms & Abbreviations Used Below:

- **MCLG**-Maximum Contaminant Level Goal: the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- **MCL**-Maximum Contaminant Level: the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- **TT**-Treatment Technique: A required process intended to reduce the level of a contaminant in drinking water.
- **AL**-Action Level: the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.
- **MRDLG**-Maximum Residual Disinfection Level Goal: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- **MRDL**-Maximum Residual Disinfectant Level: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- **NA**: not applicable
- **ppb**: parts per billion or micrograms per liter
- **ppm**: parts per million or milligrams per liter
- **pCi/L**: picocuries per liter is a measure of the radioactivity in water
- **ug/L**: Number of micrograms of substance in one liter of water

### Period Covered by Report

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of contaminants in water provided by public water systems. The following table lists all the drinking water contaminants that we detected during the calendar year of this report. Although many more contaminants were tested, only those substances listed below were found in your water. The presence of contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. As such, some of our data, though representative, may be more than one year old.
