The wells for the Hatten Water Association have received lower susceptibility rankings to contamination.

We routinely monitor for contaminants in your drinking water according to federal and state laws. This report is based on results of our monitoring period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2022.
