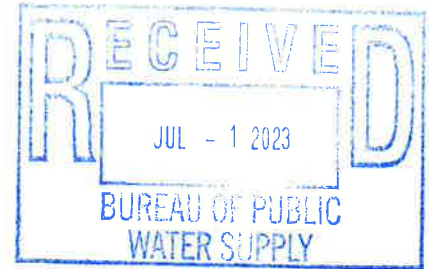

The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for our system have received lower to moderate susceptibility rankings to contamination.

**Period Covered by Report**

We routinely monitor for contaminants in your drinking water according to federal and state laws. This report is based on results of our monitoring period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2022. In cases where monitoring wasn't required in 2022, the table reflects the most recent testing done in accordance with the laws, rules, and regulations.

**VIOLATIONS**

During April 1, 2022 – June 30, 2022 we didn't complete monitoring or testing for Nitrates, Inorganic Contaminants, and Uranium and therefore cannot be sure of the quality of our drinking water during that time.

During July 2022, we didn't complete monitor or testing for Chlorine. We were required to take 7 samples and only took 5.

For the period of January 1 – December 31, 2022, test results show that our system exceeded the standard, or MCL for Disinfection By-Products. The standard for TTHM is 80 ug/L and for HAA5 is 60 ug/l. We are working to minimize the formation of TTHM while ensuring we maintain an adequate level of disinfection.

## **MONITORING AND REPORTING OF COMPLIANCE DATA VIOLATIONS SIGNIFICANT DEFICIENCIES**

During a sanitary survey conducted on 12/19/2022, the Mississippi State Department of Health cited the following significant deficiency(s): SITE SECURITY, CONDITION OF STORAGE TANKS & CROSS CONNECTION CONTROL

The system is scheduled to complete corrective actions by 5/14/2022 using a compliance plan or are within the initial 120 days minimum. Our system has failed to meet the compliance deadline and is now in enforcement status and must appear before MSDH Enforcement and the state appointed Hearing Officer. As of May 15, 2023 all Significant Deficiencies have been corrected and resolved as per letter from MSDH dated 5/26/23.

## **UNREGULATED CONTAMINANTS**

Unregulated contaminants are those for which EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulations are warranted.
