Our constant goal is to provide you with a safe and dependent supplyof drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water.

About Our System

Highpoint Water Association purchase a new 125 kw diesel generator for the #2 treatment plant. The #2 elevated storage tank was recently painted on the inside and outside. The elevated storage tank on Clark Road was pressure washed on the inside and the outside. Highpoint Water has updated the Scada monitoring system to a newer version of the VT Scada System. This program monitors all pumps and workings of the system to a computer in our office. Highpoint Water system has installed a new 15hp well pump to replace an old 10hp pump to provide better service to the customers.

Source of Water

Our water source is from wells drawing from the Lower Wilcox Aquifer. The source water assessment has been completed for our public water system to determine the overall susceptibility of its drinking water supply to identify potential sources of contamination. A report containing detailed information on how the susceptibility determinations were made has been furnished to our public water system and is available for viewing upon request. The wells for the Highpoint Water Association have received moderate rankings in terms of susceptibility to contamination.

Period Covered by Report

We routinely monitor for contaminants in your drinking water according to federal and state laws. This report is based on results of our monitoring period of January 1st to December 31st, 2022. In cases where monitoring wasn't required in 2022, the table reflects the most recent testing done in accordance with the laws, rules, and regulations.
