The well for the South Lowndes Water Association has received a lower susceptibility ranking to contamination.

We routinely monitor for contaminants in your drinking water according to federal and state laws. This report is based on results of our monitoring period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2022.
