- Shut off water while brushing your teeth, washing your hair and shaving and save up to 500 gallons a month.
- Use a water-efficient showerhead. They're inexpensive, easy to install, and can save you up to 750 gallons a month.

- Run your clothes washer and dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary.

Last year, we conducted tests for over 80 contaminants. We only detected 37 of those contaminants, and found only 1 at a level higher than the EPA allows.
