Authorized in 1994, Mississippi's **Conrad State 30 J-1 Visa Waiver** Program allows medical graduates to apply for a waiver of the two-year foreign residence requirement by directly serving patients for at least three (3) years at a health care facility located in a health professional shortage area (HPSA) or medically underserved area (MUA).
