OLD BUSINESS & STANDING AGENDA ITEMS

- **Call to Order**
 - Meeting called to order at 12:02 by Ben Richards, Trauma System Manager
- **Review & Acceptance of Minutes from Previous Meeting**

- **Follow Up: Definition – Hip vs Pelvic**
 - Injury has to involve the femoral neck in order to be a hip fracture
 - Acetabular is pelvic
