	New Business	NOTES
1.	Welcoming of New Members	The Department welcomed Mr. Robinson as the new member and introduction of staff was made.
2.	Approval of June 6, 2022 minutes	Council reviewed the June 6, 2022 minutes. Mr. Thigpen motioned for approval of all minutes, Mr. Johnson seconded, all minutes approved.
