




2013-2014 Influenza Report Week 51

December 15 – December 21, 2013

About our flu activity reporting

MSDH relies upon selected sentinel health practitioners across the state to report the percentage of total patient visits consistent with an influenza-like illness (ILI: fever of 100°F or higher AND cough and/or sore throat). Also, providers are supplied with specimen collection kits. Samples are submitted to the Mississippi Public Health Laboratory for influenza PCR testing. Reports are used to estimate the state's ILI rate and the magnitude of the state's influenza activity. Reports represent only the distribution of flu in the state, not an actual count of all flu cases statewide. **Information is provisional only and may change depending on additional reporting from sentinel providers.**

State ILI Surveillance




The state ILI rate has been slowly, but steadily increasing since week 41. During week **51** (12/15/2013-12/21/2013), the overall state ILI rate (**7.6%**) **increased** from last week

(**6.6%**), but was lower than this time last year (**11.1%**). | [Figure 1](#)



During week **51**, **four** districts (1, 3, 4, and 7) had an increase in ILI activity, while **four** districts (2, 6, 8 and 9) had a decrease. **One** district (5) remained about the same. *Information is provisional only and may change depending on additional reporting from sentinel providers.* | **Table 2**






Since week 35, the percentage of reported ILI cases has been highest among those in the **5-24 years** of age group. During week **51**, the

The 2013-14 state ILI rate was **above** the national, Region 4, and the state baselines for week **51**. | [Figure 3](#)




Mississippi ILI Rates 2010-2013 | [Figure 4](#)



Flu Testing Reports

From week **40** (week ending October 5th) through week **51** (week ending December 21st), **70** positive influenza samples were identified by MSDH. Sixty-eight (68) of the samples were identified as influenza A (2009 H1N1). Two samples were identified as influenza A (subtype not performed).

The influenza cases were identified from the following counties: Alcorn (1), Chickasaw (1), Covington (1), Forrest (4), George (1), Grenada (1), Harrison (13), Jackson (16), Lawrence (1), Lee (7), Marion (1), Marshall (4), Monroe (4), Neshoba (1), Oktibbeha (4), Pearl River (1), Prentiss (1), Stone (1), Tate (3), Washington (3), and Yalobusha (1). | [Figure 5](#)




National and Mississippi Pediatric Mortality Surveillance

One influenza-associated pediatric death that occurred during the 2012-2013 season was reported to CDC during week **51** and was associated with an influenza B virus. **Four** influenza-associated pediatric deaths have been reported for the 2013-2014 season. Mississippi has had **no** influenza-associated pediatric deaths reported during this influenza season.

National ILI Surveillance


For week **51**, the MS ILI rate (7.6%) continued to remain **above** the national ILI rate (3.0%). | [Figure 6](#)

Level of Flu Activity	Definition
No Activity	Overall clinical activity remains low and there are no lab confirmed cases.
Sporadic	Isolated cases of lab confirmed influenza in the state; ILI activity is not increased <u>OR</u> A lab-confirmed outbreak in a single institution in the state; ILI activity is not increased.
Local	Increased ILI within a single region AND recent (within the past 3 weeks) laboratory evidence of influenza in that region. ILI activity in other regions is not increased <u>OR</u> two of more institutional outbreaks (ILI or lab confirmed) within a single region AND recent (within the past 3 weeks) lab confirmed influenza in that region. Other regions do not have increased ILI and virus activity is no greater than sporadic in those regions
Regional	Increased ILI in at least 2 regions but fewer than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions <u>OR</u> Institutional outbreaks (ILI or lab confirmed) in at least 2 regions but fewer than half of the regions AND recent lab confirmed influenza in the affected regions.
Widespread	Increased ILI and/or institutional outbreaks (ILI or lab confirmed) in at least half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the state.

During week **51**, influenza activity **continued to increase** in the United States.¹ | [Figure 7](#)











