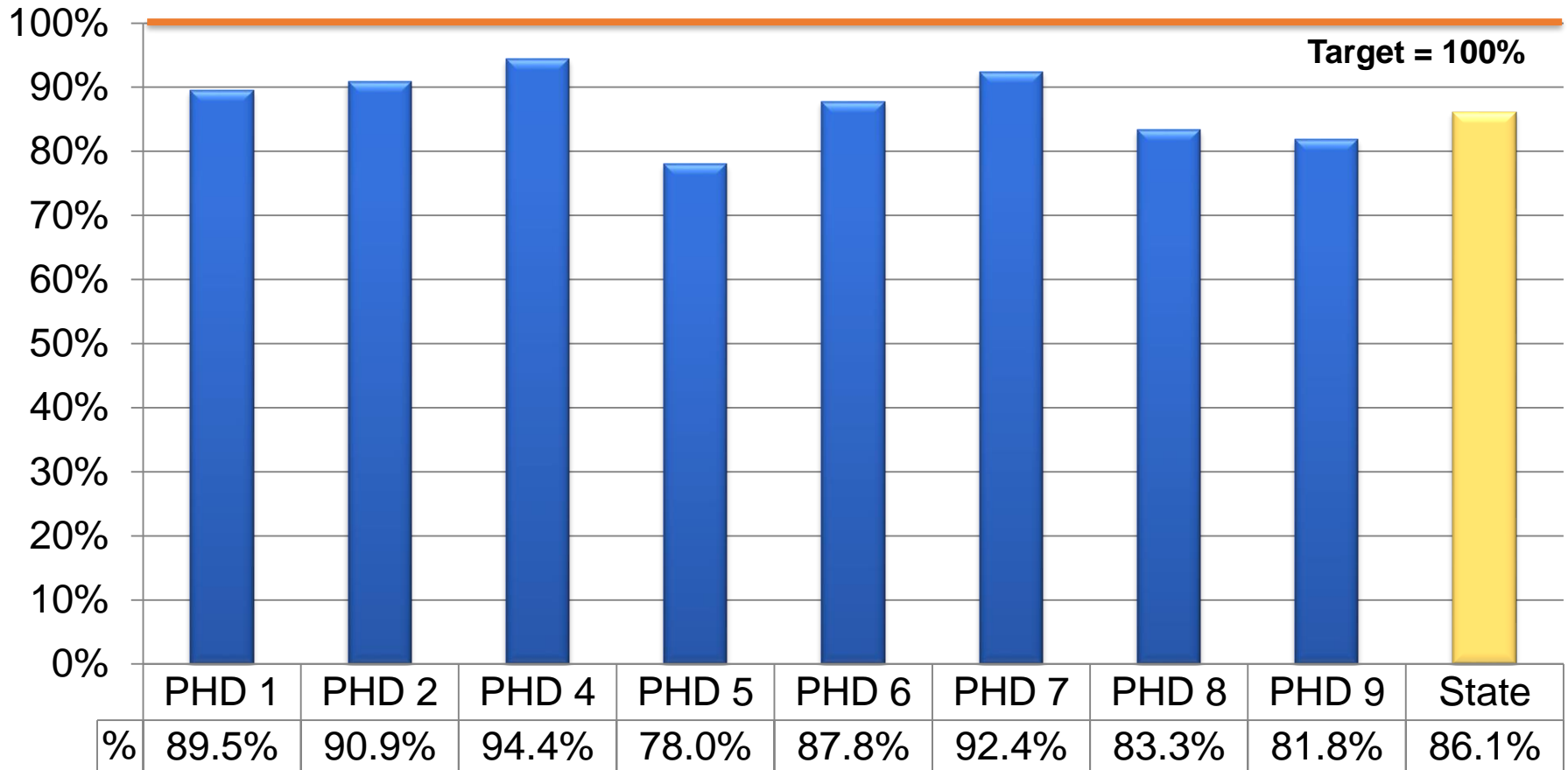

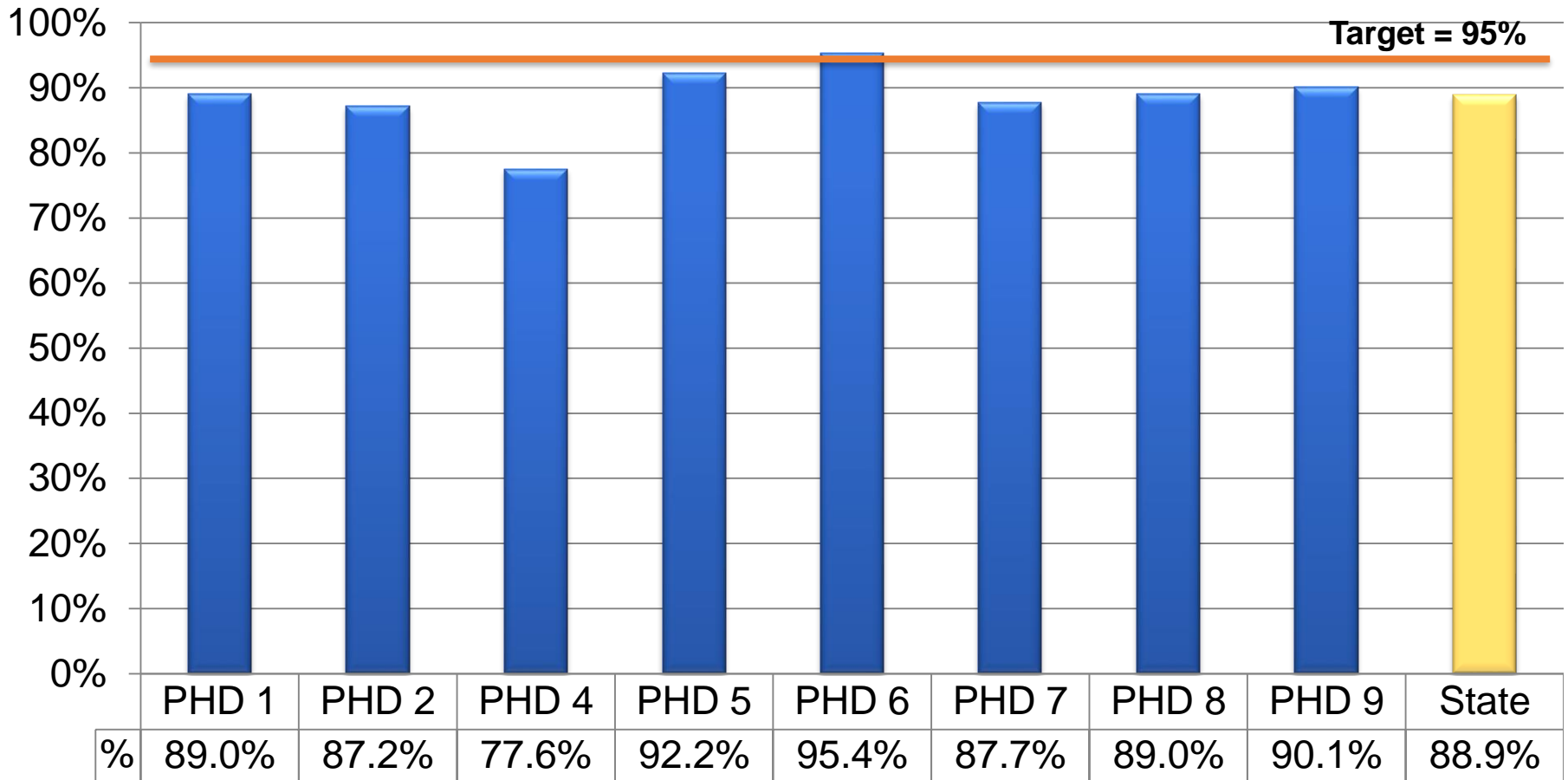

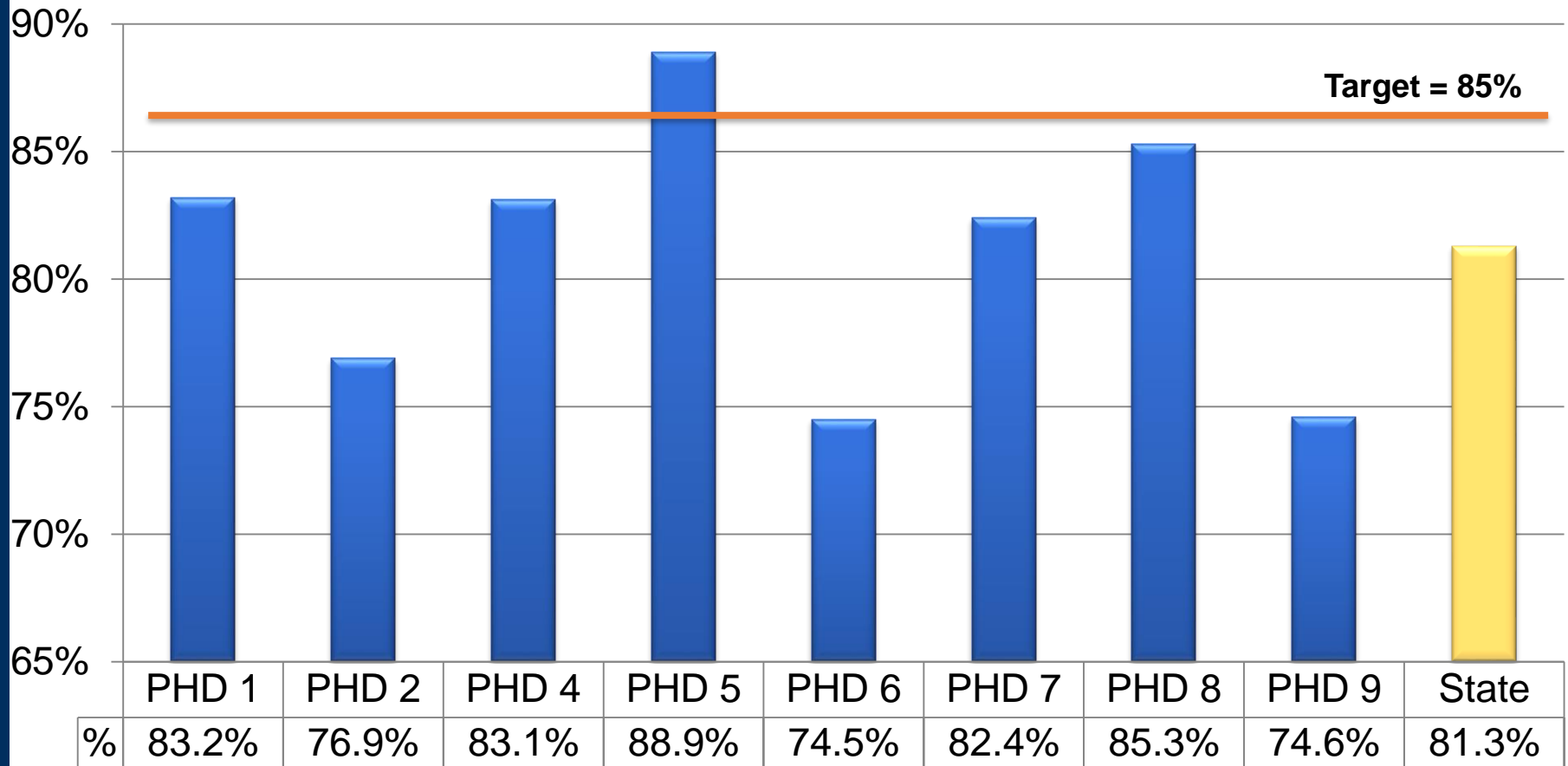

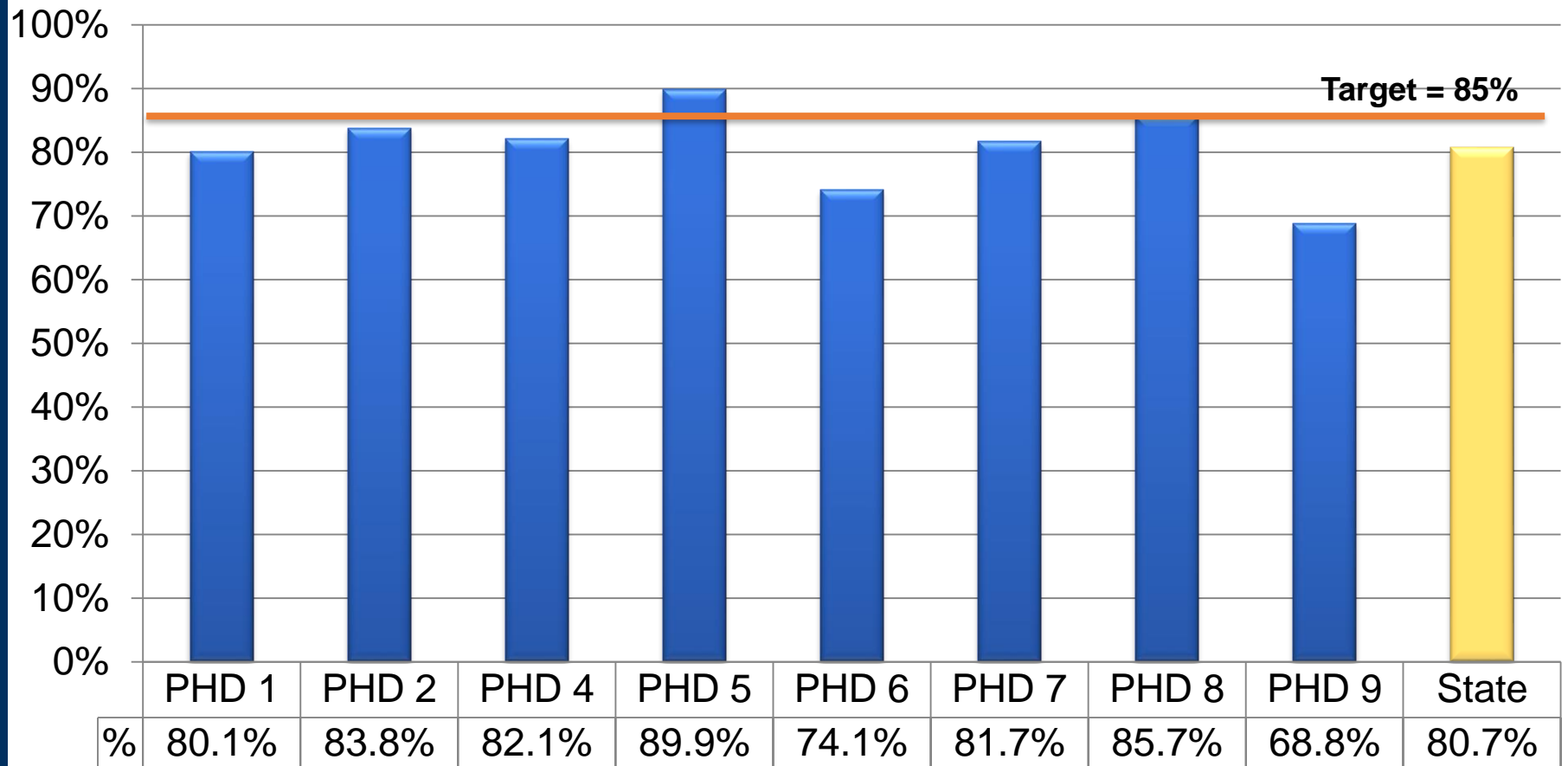
Indicator 3-A1: Early Childhood Outcomes

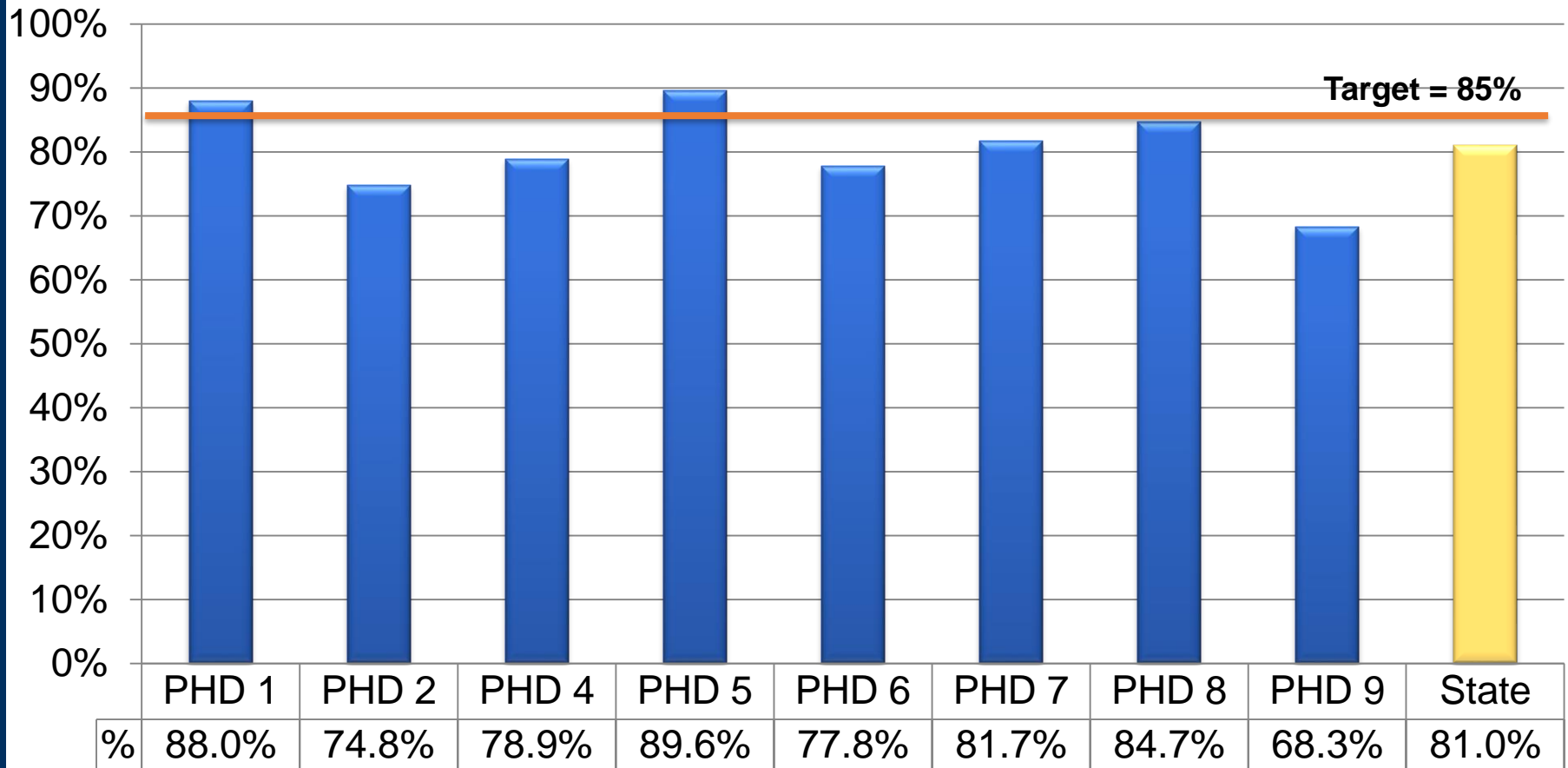
Indicator 3-B1: Early Childhood Outcomes

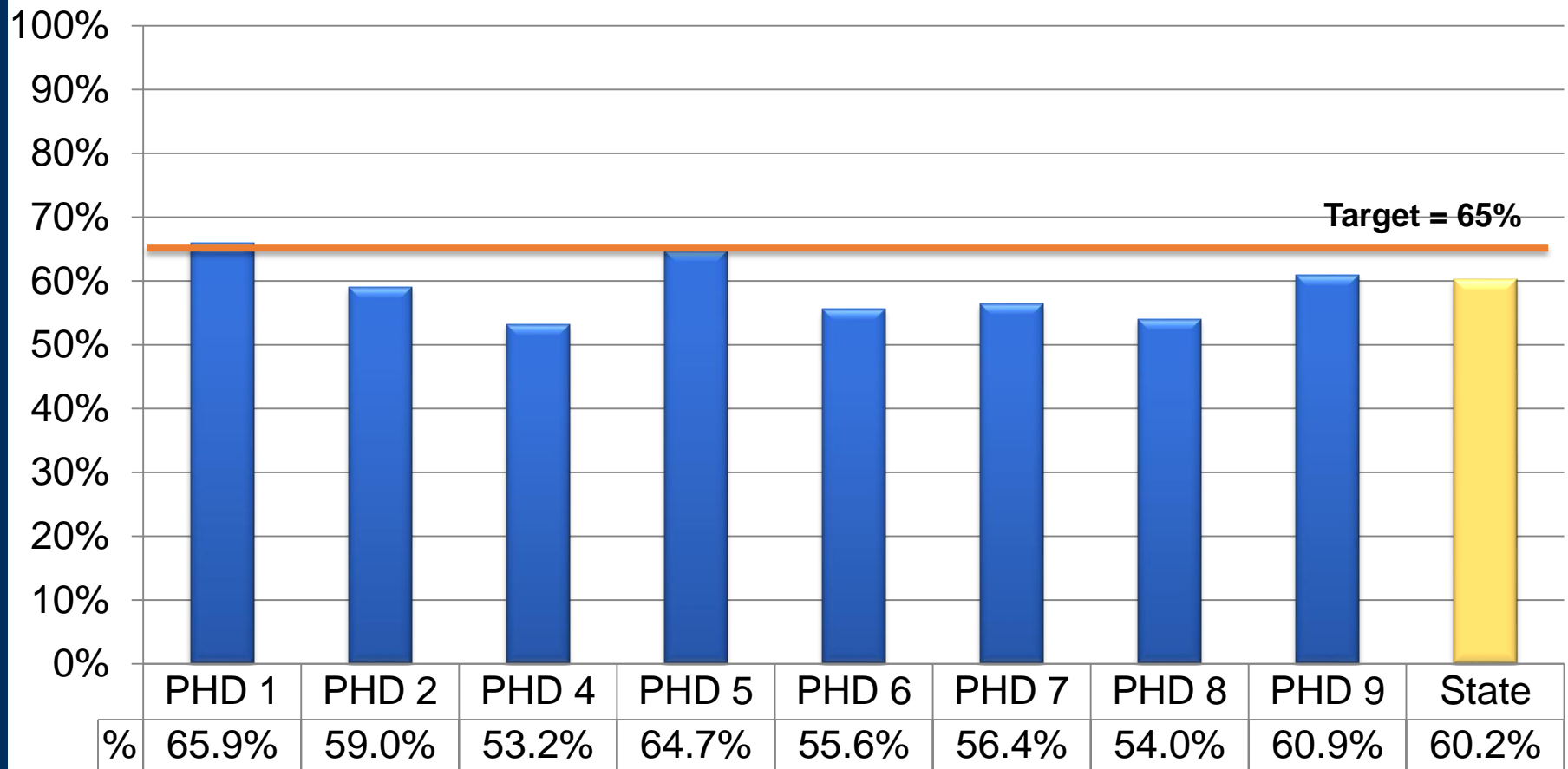

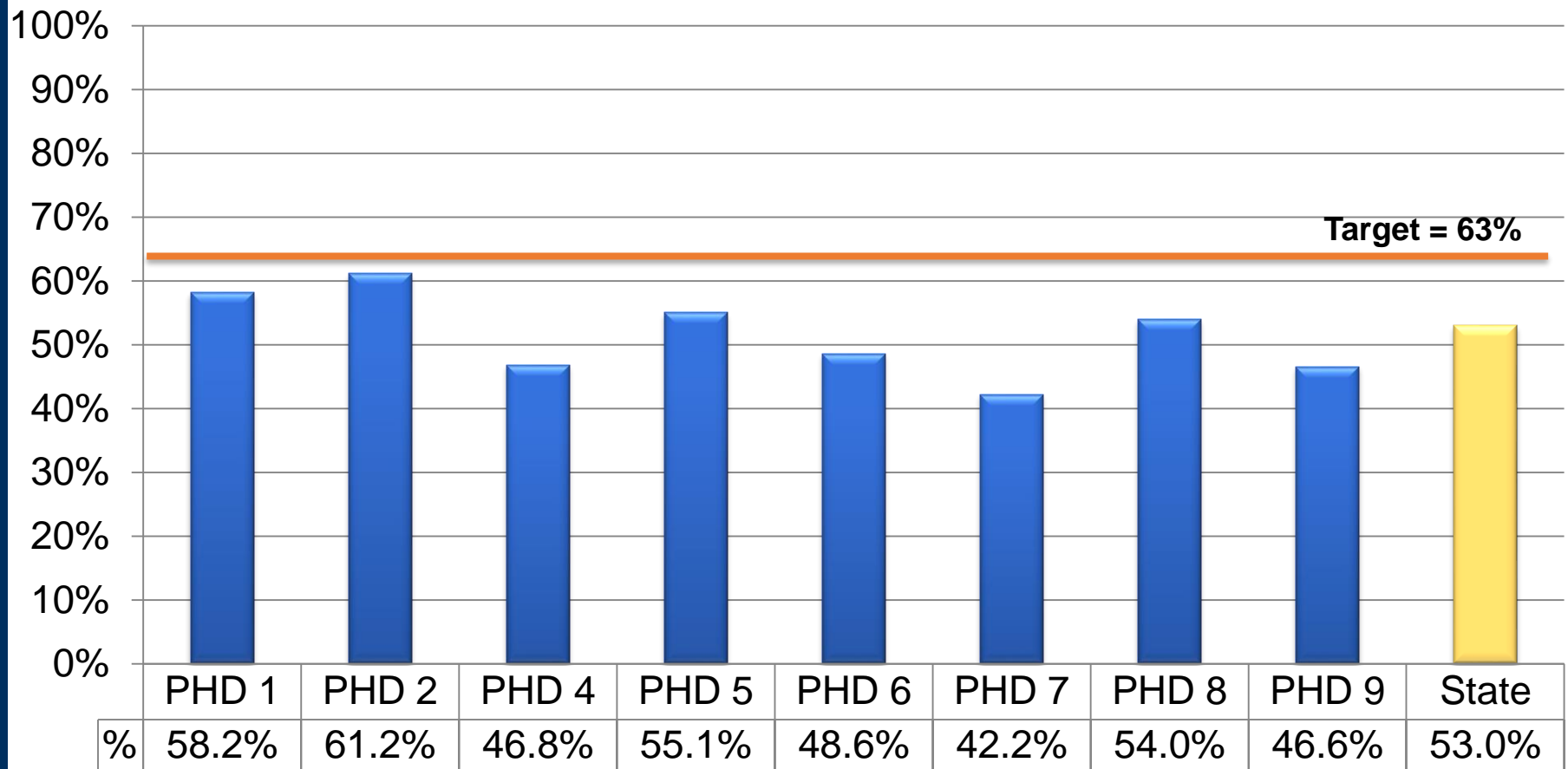

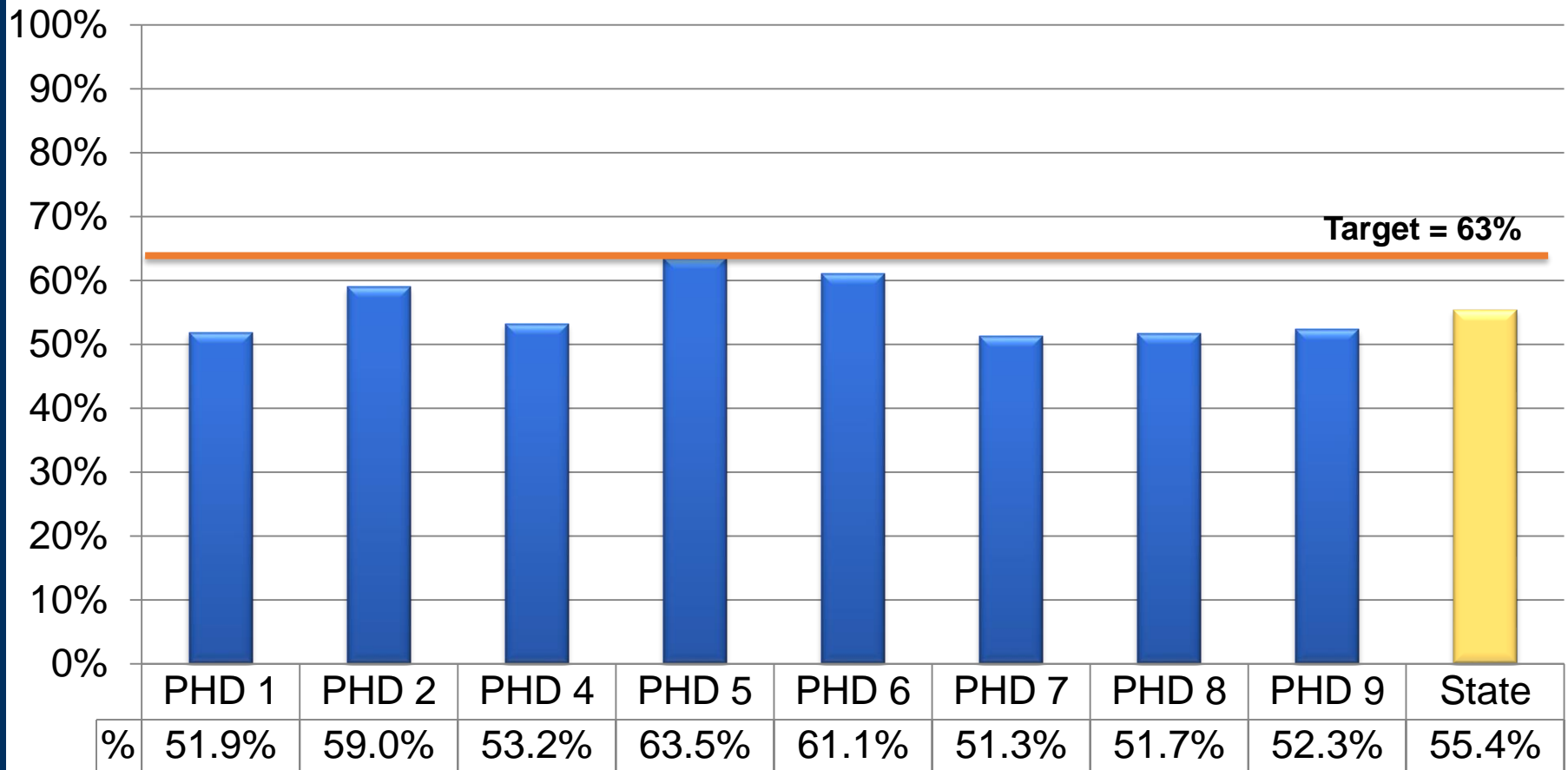
Indicator 3-B2: Early Childhood Outcomes

B - Effectively communicate their children's needs

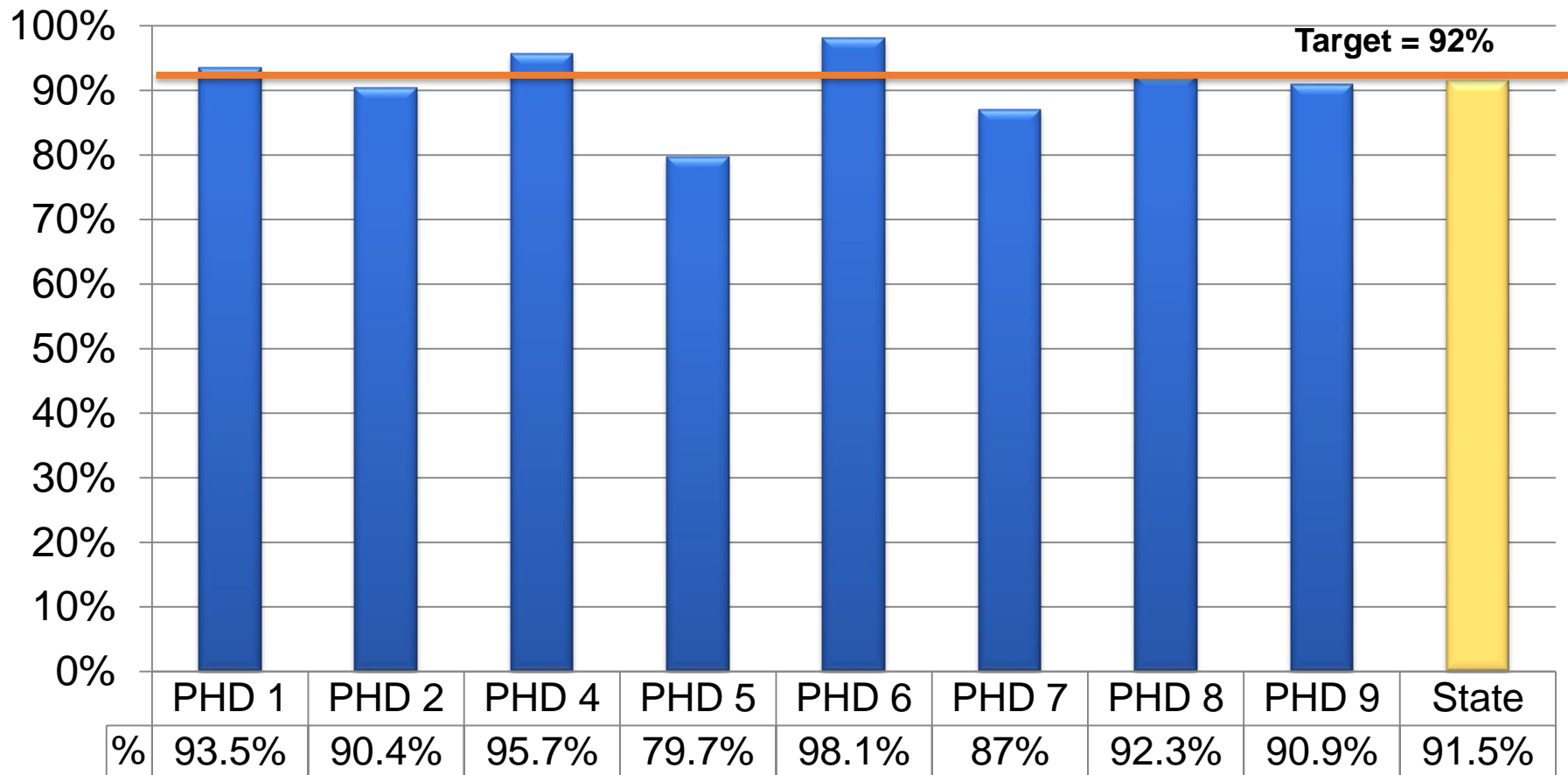

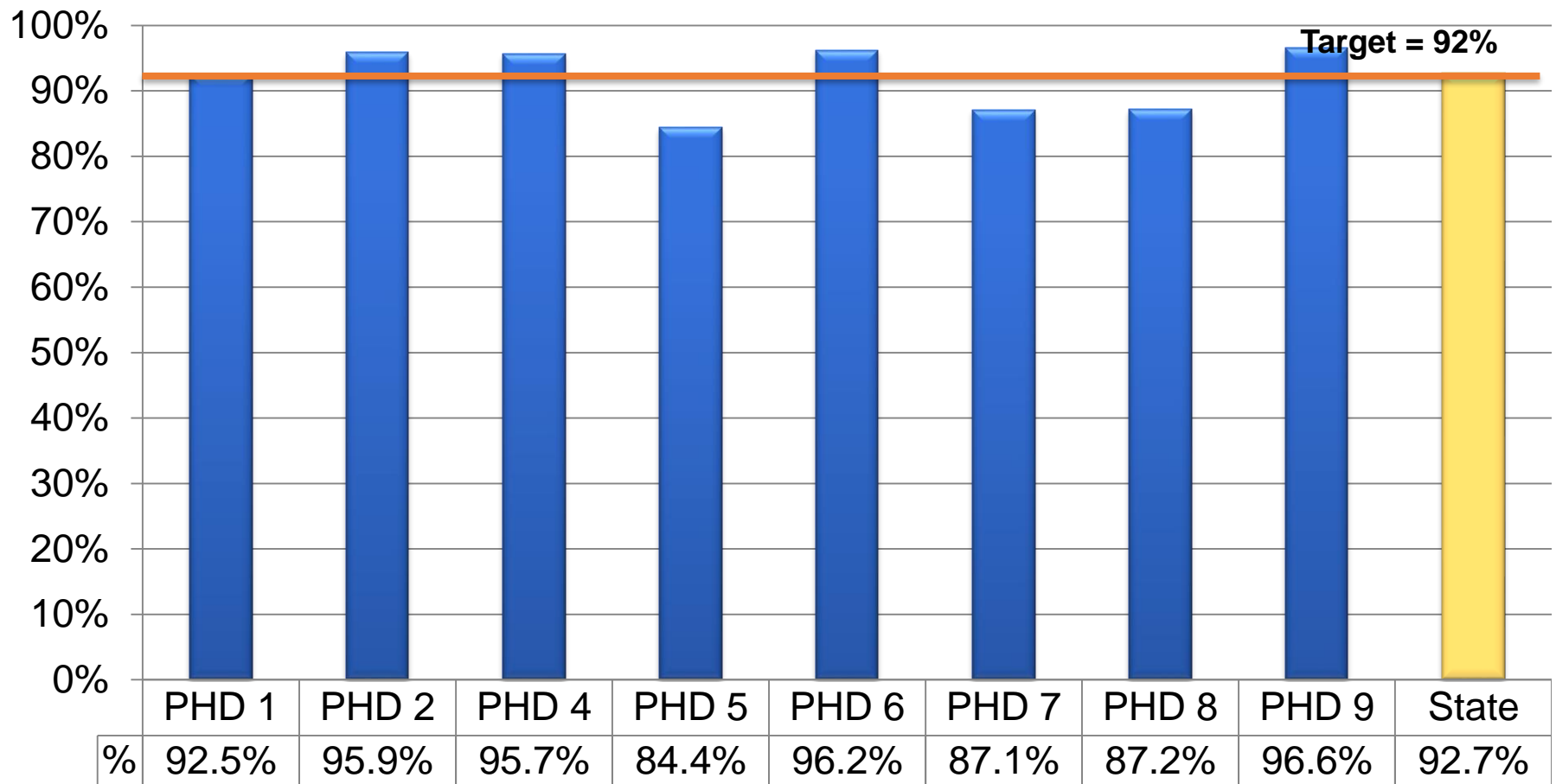

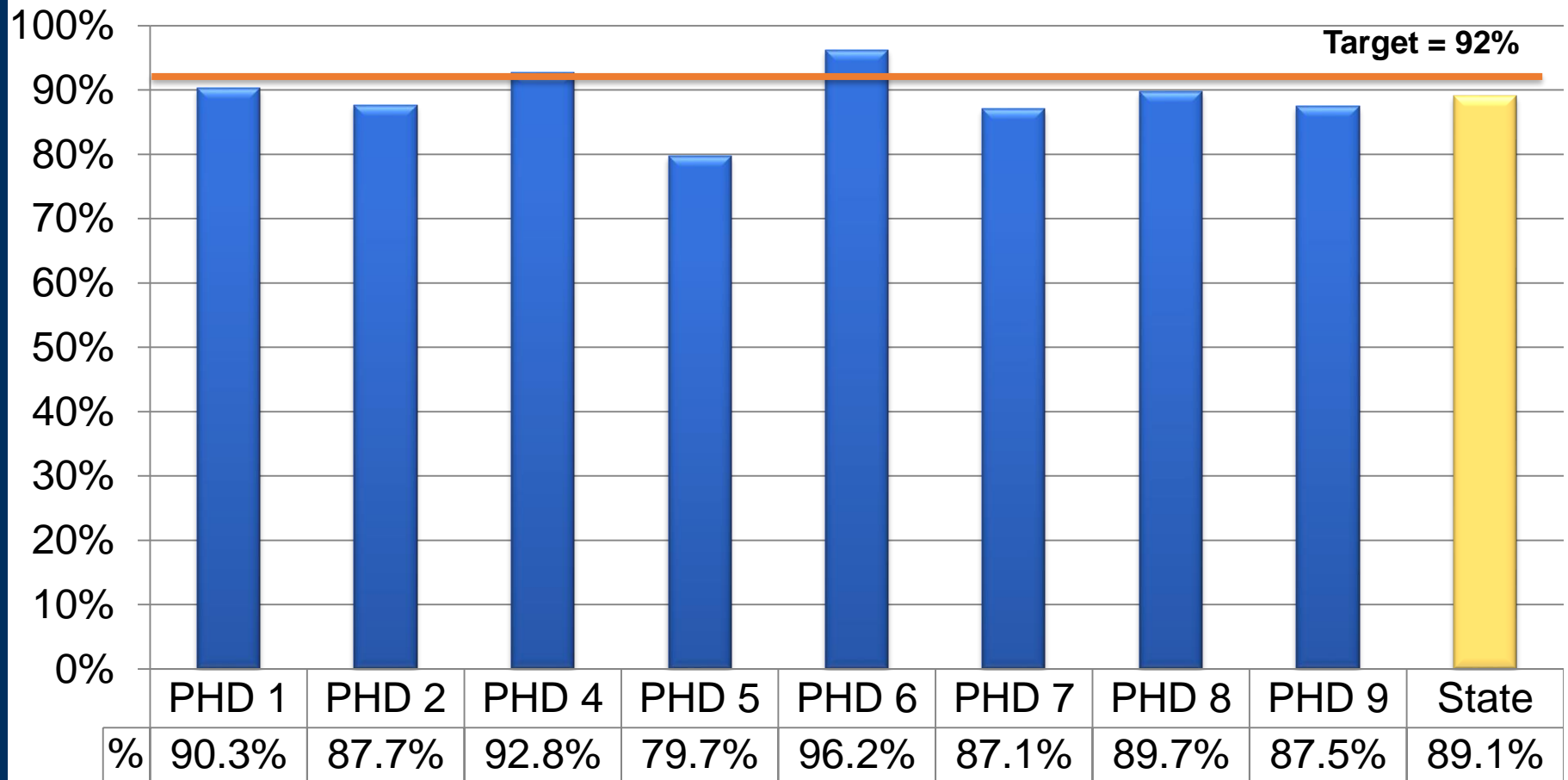
Indicator 4B: Family Outcomes

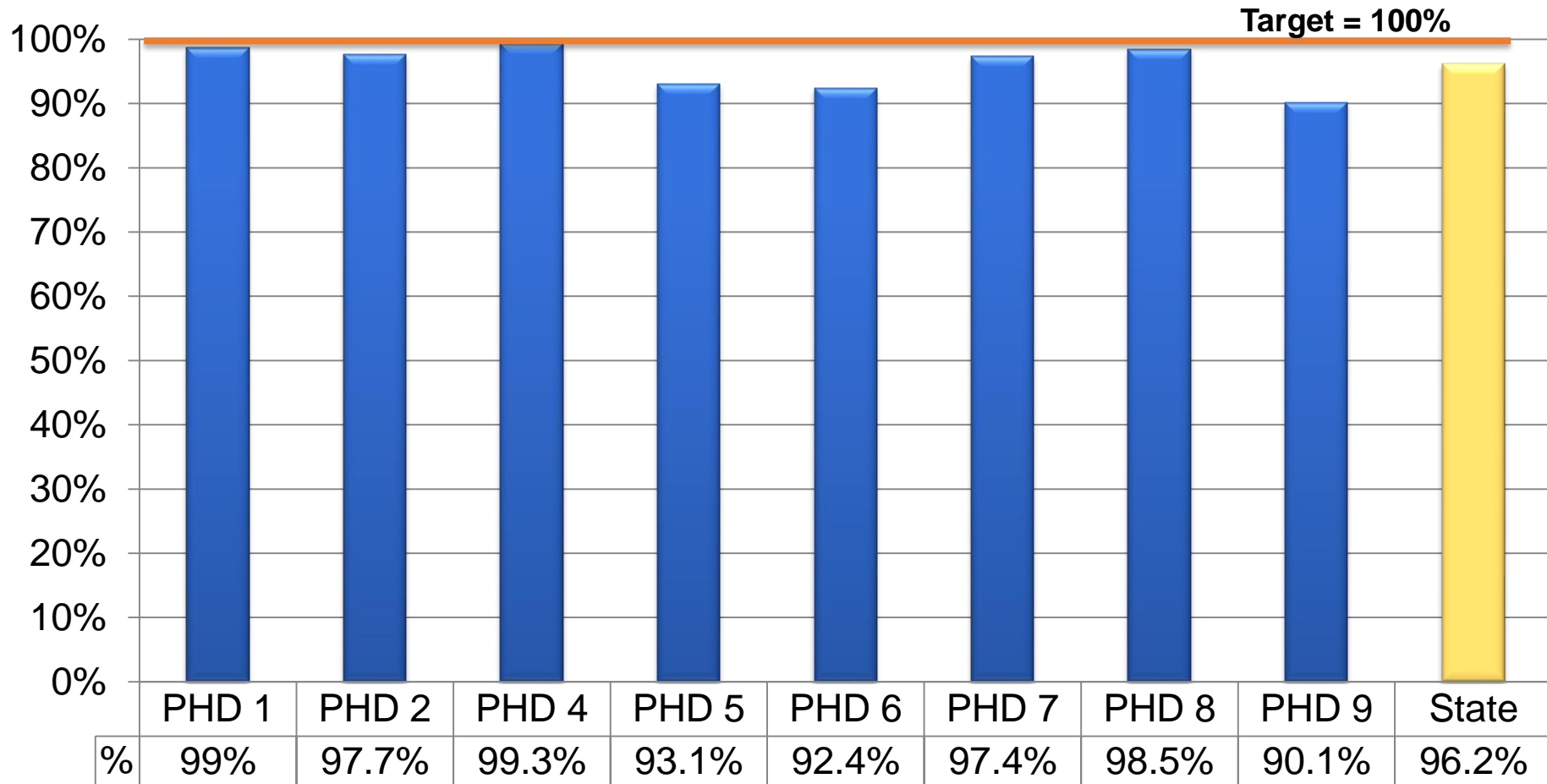

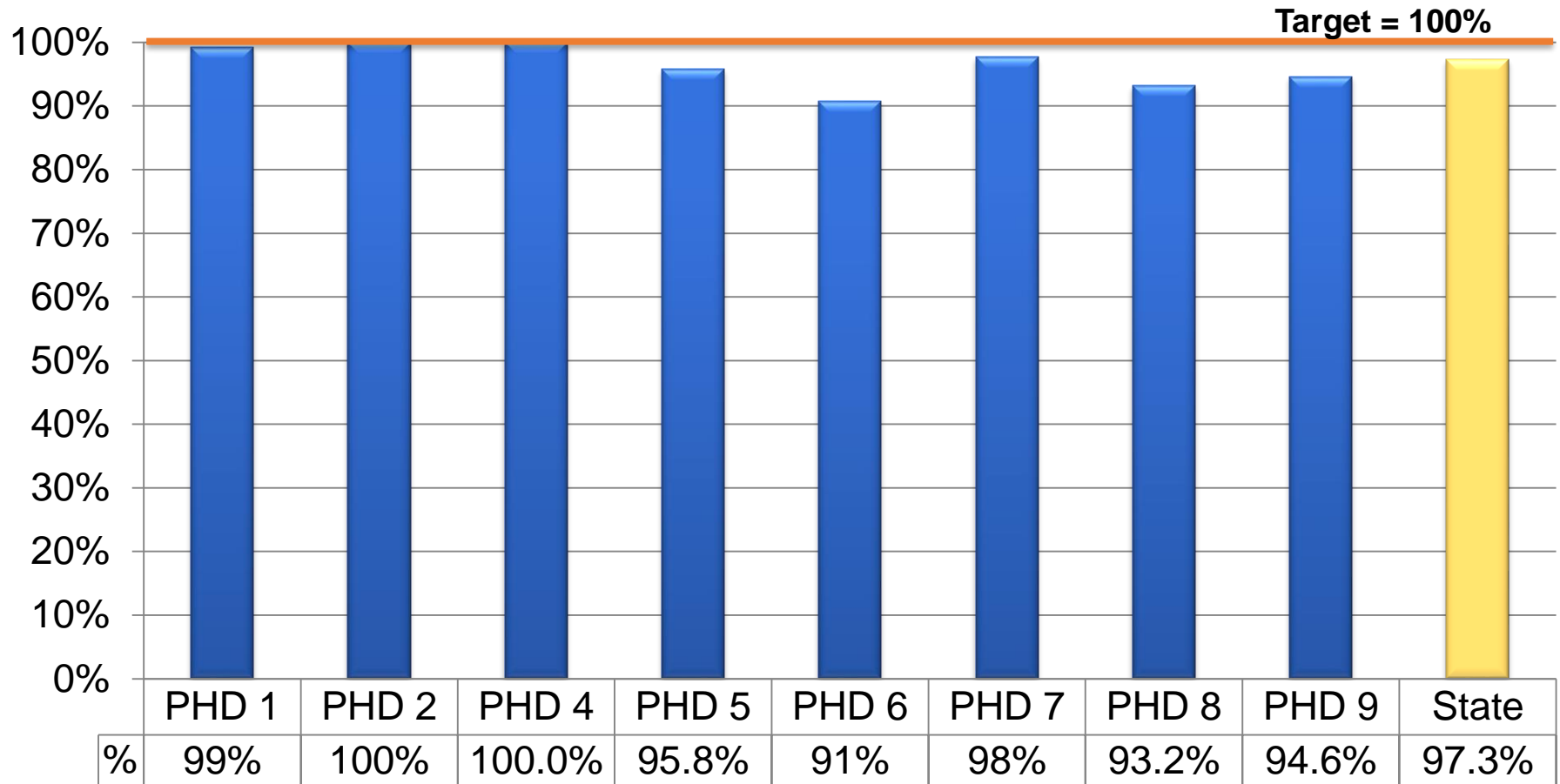
- A - Developed an IFSP with transition steps and services at least 90 days, and at the discretion of all parties, not more than nine months, prior to the toddler's third birthday

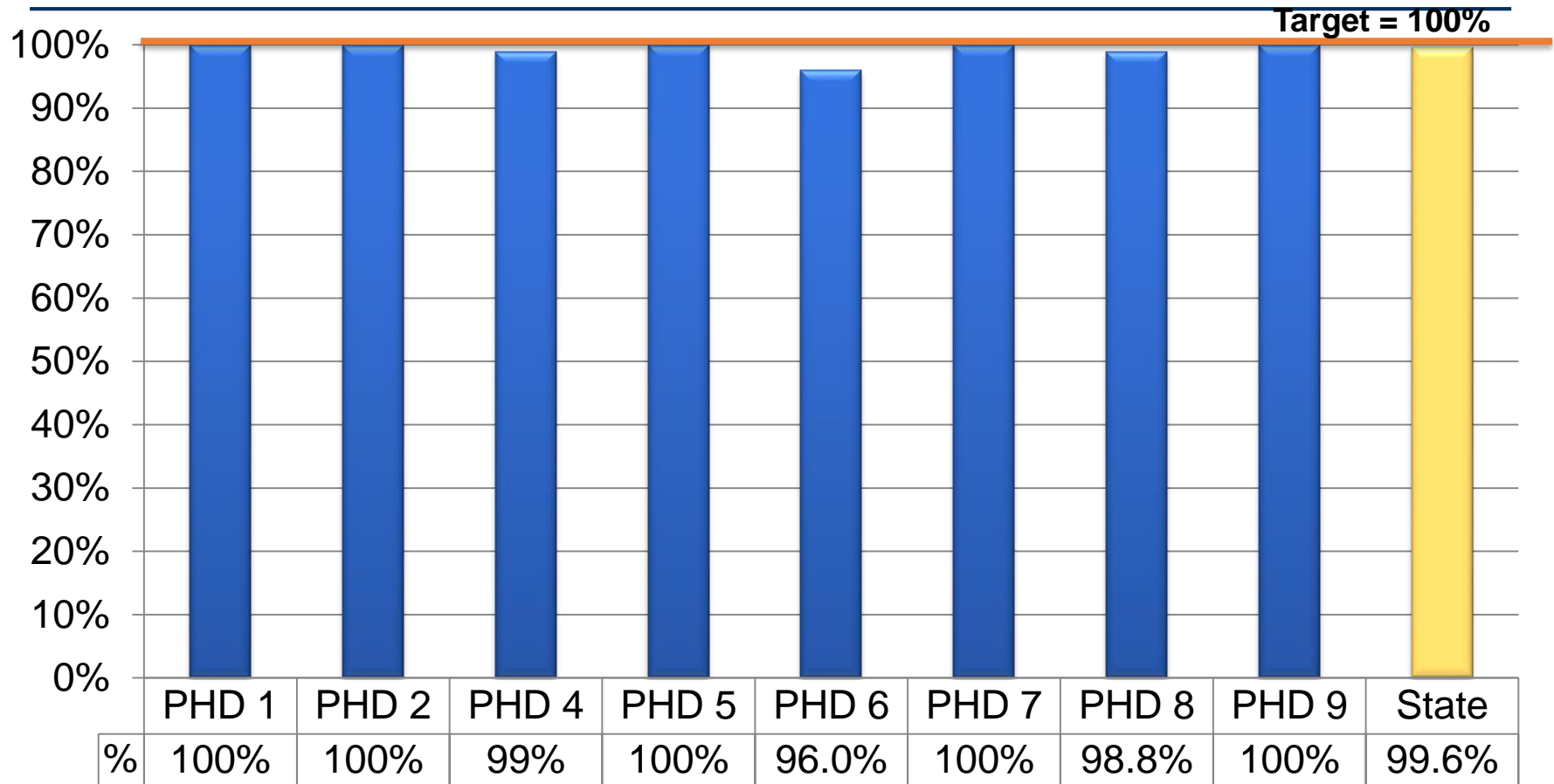
