	Old Business	NOTES
1.	Status of Council Nominations	Ms. Morrow informed the Council that she has received nominations for the clinical dietetics' member, the dietetics education member, the community nutrition member, the licensed health professional member and the reappointment nomination for the public member. She stated that the Board of Health will review the nominations at the January 12, 2022, meeting. The nominees attended today's meeting.
2.	Proposed Regulation Change	Ms. Morrow informed the members that the proposed language submitted by the Council was not accepted. The propose language was: Any individual who provides nutrition recommendations for the purpose of disease prevention and wellness, nutrition information, guidance, encouragement, health coaching, holistic and wellness education, motivation, behavior change management, or non-medical weight control services, provided that the individual does not: (i) provide medical nutrition therapy as defined in Rule 3.1.3(11) or (ii) hold himself or herself out as a licensed dietitian or licensed nutritionist as prohibited under Rule 3.5.1.  The previous submitted language was accepted and the Department is awaiting a response from Legal: Any individual who provides individualized nutrition recommendations, nutrition information, guidance, encouragement, health coaching, holistic and wellness education, motivation, behavior change management, or non-medical weight control services, provided that the individual does not: (i) provide medical nutrition therapy as defined in Rule 3.1.3(11) or (ii) hold himself or herself out as a licensed dietitian or licensed nutritionist as prohibited under Rule 3.5.1.  Ms. Kingston questioned who created the accepted verbiage. Ms. Morrow explained that she created the verbiage using inform provide by Pepin Tuma
		with the Academy of Nutrition and Dietetics. Ms. Mixon asked what was unacceptable with the language that was submitted by the Council. Ms. Morrow stated she would ask the attorney about the matter and give a response to the Council and Ms. Mixon.
