	New Business	NOTES
1.	Approval of August 12, 2022 minutes	A motion was made by Ms. Buys and seconded by Ms. Roach to approve the minute of the August 12, 2022 meetings. The motion passed.
2.	Nominations/Reappointment of Members	Ms. Wang informed the council that the Bureau has received the information required for reappointments for Ms. White, Dr. Lemacks, and Ms. Madkin. The Bureau is waiting on reappointment letter of recommendation from MSAND for their reappointment term to end 12/31/2025. Ms. Wang also informed the council that a chairperson needs to be nominated for the new year to begin as chairperson for July 1, 2023. Ms. Roach nominated Ms. Madkin, Ms. Buys seconded. Ms. Madkin was appointed chairperson.
3.	Renewal Reminders	Ms. Gunn informed the council that the renewal for both provisional and regular dietitians will be open from February 1, 2023 to March 31, 2023. All regular dietitians will be able to and must renew online. All provisional dietitians will receive a renewal form and must mail it in. All renewals have to be received by March 31, 2023, otherwise, they will be late. Ms. Wang informed the Council that the 1 st renewal reminder will go out via email on February 1 st , and a 2 nd /last reminder will be emailed to those who have yet to renew no later than 3 weeks prior to the expiration date.
