IV	Reports	<p>Bureau of Acute Care Systems Report: Ms. McMillen provided updates:</p> <ul style="list-style-type: none"> Dr. Stone asked Ms. McMillen and Ms. Maurer to get with Ms. Windham on rescheduling the telehealth conference call that was canceled. <p>MHCA Report: Ms. McGregor provided updates:</p> <ul style="list-style-type: none"> The MHCA just had the quarterly STEMI coordinator and regional meetings on Oct 9th 2023. The symposium will be January 26, 2024 at the Sheraton Flowood in Flowood, MS. More information to come.
V	Performance Improvement Committee Report	<p>Performance Improvement Committee update:</p> <ul style="list-style-type: none"> Ms. McMillen presented slides with all the names and locations of the designated STEMI receiving centers. Metric 37: First medical contact – device time (%) 2023Q2 R4Q. State Aggregate US 5th Percentile: 86.5% 2023Q2 R4Q. MS was down 2%. Some possible contributors that we found could explain this R4Q downward trend. A 4% decrease of patients receiving EKGs within 10 minutes can contribute to this. Some data entry platform calculations discrepancies with NCDR are being examined both at the hospital system level and the NCDR level. The Door to balloon time for MS is 62 minutes, we are doing very well. The states in the South-Central Region are MS, KY, TN, and AL. This was put in by Ms. Windham and it was very helpful. Star performers shared. Metric 4902 (11013): Median time (min) FMC to device. Goal: Median Time ≤ 90 Minutes 2023Q2. MS has an increase of 2 min. A few hospitals had very prolonged per-hospital EKG median times. We also had a bigger increase in hospital arrival to ECG time. Metric 56: 56 – Time to Primary PCI Among Transferred Patients. National and State Benchmarks. US 50th Percentile: 77.9% 2023Q2 R4Q. This metric has some exclusions. The ≥ 45 min and time to first activation device is ≥ 120 min, will be taken out of this. We still dropped a little by 5.3%. Top performers for transferred patients are Magnolia Regional, Anderson and Forrest General. The R4Q MS was at 65.0% Metric 4922: Median time (min) from first facility ED arrival to primary PCI (transferred acute STEMI). (Transfer) National Rankings. Goal: Median Time ≤ 120 min 2023Q2 R4Q: No Thrombolytics
